

A little background information

- 23 Stores in East Tennessee
- Receiving electronic pricebook files from one vendor
- Receiving electronic invoice files from 5 vendors
- Working on a beverage vendor for electronic files now
- Electronic payments with 2 large trade vendors
- Working on electronic payments for one more now.







More imports

- Fuel BOL (bill of lading)
- Fuel invoices

- Supplier EFT imports
- Bank statements
- Credit card recon



What's in it for me?

- Labor savings invoice imports save your store manager's time. We save over \$23,000 per year on a vendor with numerous cost issues.
- Labor savings Administration labor also decreases with fewer errors to correct. Items hit inventory correctly. Invoices hit accounts payable correctly. Reduce missed invoices.

What's in it for me?

- Labor savings Accounts payable labor is reduced by electronic statements and electronic payments.
- Implementing electronic payments can reduce your banking costs also.
- No more beer checks.





What's in it for me?

- Accurate data invoice imports save admin by getting data in the system correctly. The merchandise is received at item without human labor.
- Accurate data inventory is cleaner which provides the operations team with better information for loss prevention and more.



"INVOICE"

 I receive PDN, ASN, and invoice documents – I use all of these as an "invoice" – meaning I update inventory and accounts payable with these electronic documents.





ROADBLOCKS

 I use PDN (pre-delivery notification) and ASN (advanced shipment notice) to overcome a roadblock that has hindered implementation in our retail channel. PDN and ASN are normally delivered the day of delivery. No lag time.

Conexxus: How Much can you save with Electronic Data?



Include your entire supply chain

- We send orders electronically to grocery supplier.
- We also send credit requests to grocery supplier.
- We send sales data to an retail analytics company, and suppliers – this can provide a small revenue stream.
- Keep looking for processes that provide savings through electronic data.



STRONG FOUNDATION

 A strong, living pricebook is critical to electronic invoices. You cannot walk this path without committing to the heavy lifting on your pricebook.
